Binding requirements and notes:

1. Any requests for film and photo shoots in properties owned by the State of Bavaria - in the Bavarian State Spa Bad Brückenau - must be submitted by written request to the State Spa Administration no later than 10 working days in advance. This does not apply to recordings for daily reporting.
2. With your signature/company stamp, you agree to recognise the binding conditions/instructions in full.
3. Proof of the applicant's existing public liability insurance for personal injury and material damage must be enclosed with this application and is a precondition for a film/photo permit. The applicant is liable to the State Spa Bad Brückenau Administration for any personal injury or damage to property arising in connection with or as a result of the film/photo work.
4. In principle, film and photo authorisations are subject to a charge if the administrative fee incurred is not covered by the image motifs/simple right of use. All ancillary costs (personnel/operating costs) incurred in connection with the filming shall be borne by the applicant.
5. As a rule, the following scope of rights is automatically included in film licences: broadcasting as often as desired within the broadcasting family in German-speaking countries (or in the case of foreign broadcasters in the national language), publication on the homepage or in social media channels of the broadcasting family, one-year term.
6. In the case of photo authorisations, five printable photos must be submitted to the State Spa Administration for unrestricted, free publication; alternatively, a fee of € 125.00 zzgl. VAT will be charged. As the sole owner of all unrestricted rights to the photos and visual representations to be provided, the author of the image grants the State Spa Administration the exclusive rights of use in Germany and abroad without restriction. The author of the image assures that they may freely dispose of the unrestricted rights of use to the image material, that it is free of third-rights and that the persons pictured agree to its publication.
7. When filming/photographing, all activities that could cause a public nuisance are prohibited. Changing clothes in public and revealing behaviour are an offence that will result in expulsion, as will playing music and climbing trees/parts of buildings.
8. Driving and parking motor vehicles in the castle park area is expressly prohibited.
9. The authorisation/rejection of the application is made in writing and is only valid for the purpose applied for here. The authorisation must be carried during the filming/photo shoot and presented on request if necessary.
10. The citation rule: Bavarian State Spa Bad Brückenau ® 2026.
11. The applicant assures that the image material will not be used for the purposes of unauthorised or punishable acts or in a manner damaging to the redundant reputation.
12. We treat the data you provide in strict confidence in accordance with the statutory provisions. Unauthorised disclosure to third parties will not take place. We will process and use your personal data insofar as this is necessary for the processing, realisation and handling of your enquiry.
